## Overtime

NorCal NECA would like to refresh everyone's memory about the different provisions concerning overtime in the Collective Bargaining Agreement's NorCal NECA negotiates. To compliment the information in the below article, we have put together a helpful spreadsheet highlighting the different overtime/double time provisions. We have also included the Chapter's 2021 holiday calendar, which can be found on the second page of this spreadsheet. The spreadsheet can be found on pages three and four of this document.

Workday/Workweek: Eight hours work between 7:00 AM - 4:30 PM (with 30-minute lunch) Monday through Friday constitutes the workday and workweek. The workday can be varied by one-hour with mutual consent of the parties.

Overtime: The first two (2) hours after the regular workday will be paid at time and one-half $(1-1 / 2)$ the regular straight time rate.

Double Time: All other work performed outside the regularly scheduled working hours, and work on Saturdays, Sundays and holidays, shall be paid at double the straight time rate of pay.

## San Joaquin and Calaveras Counties - IBEW Local Union 595E <br> Section 3.02

Workday/Workweek: Eight hours work between 7:00 AM - 3:30 PM (with 30-minute lunch) Monday through Friday, constitutes the workday and workweek. Working hours may be changed by one-hour to conform with weather conditions, the needs of a particular job or to coincide with other crafts upon mutual consent of the parties.

Overtime: The first two (2) hours before or after the regular workday will be paid at time and one-half ( $1-1 / 2$ ) the regular straight time rate. Further, the first eight (8) hours on Saturday will be paid at time and one-half (1-1/2).

Double Time: All other work performed outside the regularly scheduled working hours and on Sundays and holidays, shall be paid at double the straight time rate of pay.

Workday/Workweek: Eight hours work between 6:00 AM - 4:30 PM (with 30-minute lunch) Monday through Friday, constitutes the workday and workweek. Working hours may be changed to conform with weather conditions, the needs of a particular job or to coincide with other crafts upon mutual consent of the parties.

Overtime: The first two (2) hours following the regular workday will be paid at time and onehalf $(1-1 / 2)$ the regular straight time rate. Further, the first eight (8) hours on Saturday will be paid at time and one-half ( $1-1 / 2$ ).

Double Time: All other work performed outside the regularly scheduled working hours, and work on Sundays and holidays, shall be paid at double the straight time rate of pay.

Workday/Workweek: Eight hours work between 7:00 AM - 3:30 PM (with 30-minute lunch) Monday through Friday, constitutes the workday and workweek. The workday can be varied by one-hour with mutual consent of the parties.

Overtime: The first two (2) hours following the regular workday will be paid at time and onehalf $(1-1 / 2)$ the regular straight time rate. Further, the first ten (10) hours on Saturday will be paid at time and one-half (1-1/2).

Double Time: All other work performed outside the regularly scheduled working hours, and work on Sundays and holidays, shall be paid at double the straight time rate of pay.

## Sound and Communication Division $-9^{\text {th }}$ District Addendum No. 2 <br> Section 3.01

Workday/Workweek: Eight hours work between 6:00 AM - 6:00 PM (with 30-minute lunch) Monday through Friday, constitutes the workday and workweek.

Overtime: The first four (4) hours following the regular workday will be paid at time and onehalf $(1-1 / 2)$ the regular straight time rate. Further, the first eight (8) hours on Saturday will be paid at time and one-half ( $1-1 / 2$ ).

Double Time: All other work performed outside the regularly scheduled working hours, and work on Sundays and holidays, shall be paid at double the straight time rate of pay.
