The December 1, 2025, the wage was increased by \$1.49, the Pension increased by \$1.00, the Health & Welfare increased by \$1.25, the HRA increased by \$0.35.

¹ Effective December 1, 2023, Wage increases are 90% of the actual Schedule A wage increase.

² Effective December 1, 2022, the membership voted to fund their Vacation Account with a flat 6% withholding from the wage rate.

³ First Bracket Apprentices (55%) indentured after December 1, 2023 will not receive a Pension Contribution.

Second Bracket Apprentices (60%) indentured after December 1, 2023 will receive 50% of the Installer Pension Contribution.

All Remaining Brackets will receive 100% of the Installer Pension Contribution.
